Paper-based systems can cause significant delays in processing these essential documents.

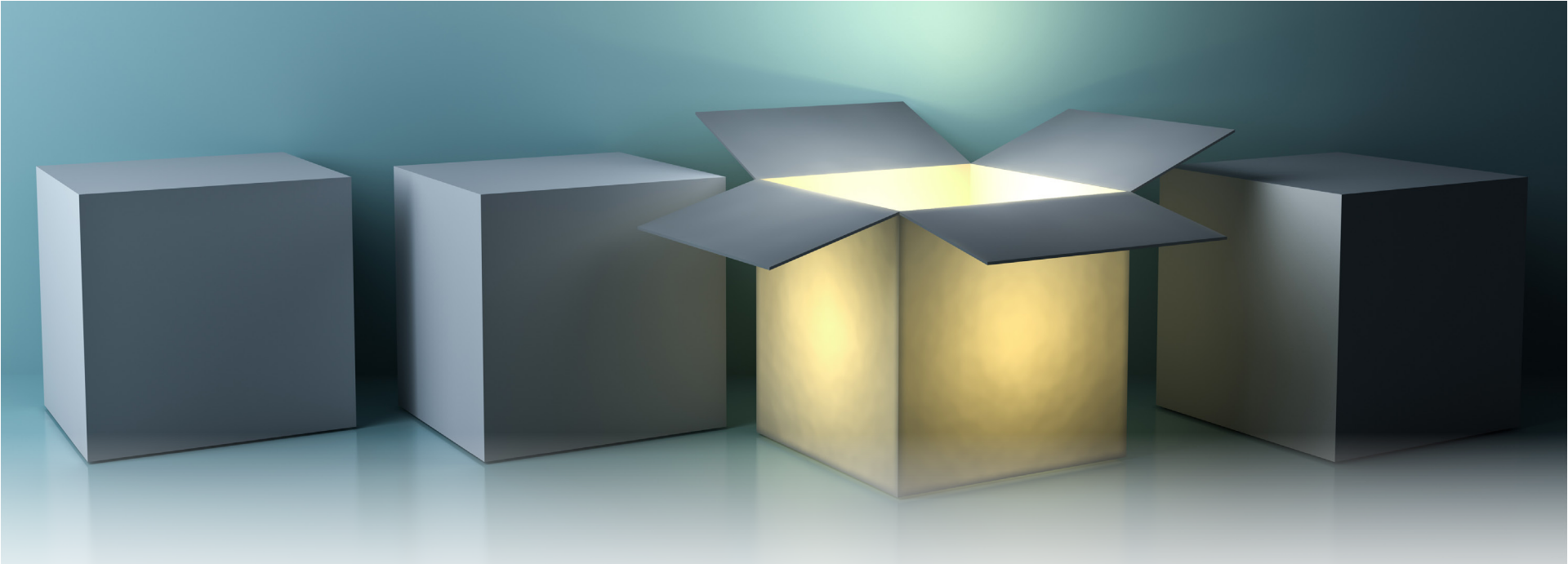
